We give The Academy our permission for any resulting photographs or video of our animal to be used for advertising or educational material, understanding that the resulting photographs or videos are the sole property of The Academy of Canine Behavior's.

Any legal expenses incurred in defense or enforcement of this contract shall be the total responsibility of the owner of the animal.
